No.2507 (Group-N) dated 26/02/2014 for release of a one time grant of Rs.5,000/- (Rupees five thousand) only in favour of each of the 706 nos. of Schools (Madhyamik and Higher Secondary) located in Kolkata and a one time grant of Rs.10,000/- (Rupees ten thousand) only in favour of each of 100 nos. of Colleges located in Kolkata only along with one time grant of Rs.25,000/- (Rupees twenty-five thousand) only in favour of each of the Universities located in Kolkata as detailed below: i) Calcutta University. ii) Jadavpur University. iii) Rabindrabharati University. iv) Presidency University. - for procurement of Sports Goods as per this requirement.

An amount of Rs.46,30,000/- (Rupees forty-six lakh thirty thousand only) is hereby sanctioned and released and placed at the disposal of the Assistant Director, School Education (Physical Education) from the available balance under the head of Account –“2204-Sports & Youth Services-00-102-Youth Welfare Programmes for Students-SP-State Plan (Annual Plan & XIIth Plan)-003-Development of Rural Sports[YS]-V-31-Grants-in-Aid-GENERAL-02-Other Grants”during the current financial year, augmented by same amount of Rs.46,30,000/- (Rupees forty-six lakh thirty thousand) only by way of re-appropriation from the Budget Provision under the head of accounts ”2204-Sports and Youth Services-00-103-Youth Welfare programmes for Non Students-SP-State Plan (Annual Plan and XIIth Plan)-015-Mini Indoor Games/Recreation Complex[YS]-V-31-Grant-in-Aid-GENERAL-02-Other Grants” during the current financial year under the Demand No.49.

He will take necessary action for collecting the utilization certificates from the grantee institutions and submission of the same to this Department in due course.
